Its primary responsibilities include resolving disagreements on legal interpretations between the Council of Ministers and the Parliament, reviewing and drafting amendments to the constitution, proposals of laws, decrees, regulations and decisions, publishing legislation in the Official Gazette, interpreting law provisions and providing legal opinions on various matters, reviewing international treaties to ensure compliance with the constitution and the Kingdom's sovereignty, expressing opinions on government contracts, reviewing government-owned companies' foundational documents, and organizing and supervising the electoral process in Bahrain.
