Stephen also advises and represents clients, both government and non-governmental, in matters of public international law and dispute resolution, including in disputes involving maritime delimitation and transboundary resource management. He was a negotiator for Canada in the renewal of the Canada-U.S. Pacific Salmon Treaty and counsel to Canada in the mediation of disputes arising under that Treaty. He was counsel before an international tribunal constituted to determine the offshore boundary between the provinces of Nova Scotia and Newfoundland and Labrador. He was an adviser to the Secretary General of the United Nations and mediator in a territorial and resource dispute between Gabon and Equatorial Guinea. And he was a neutral evaluator in an international dispute involving government and private parties in the Middle East.

Among the several professional associations of which he is an active member, Stephen is a former Chair of the Arbitration Committee of ICC Canada, the Canadian National Committee of the ICC.
