Author or co-author of more than 20 books and more than 200 articles in the field of arbitration and alternative dispute resolution.

#### Experience in arbitration:

Since 1988, has been actively involved in international arbitration, as counsel at the secretariat of an arbitration institution, as chairman, sole arbitrator, party-appointed arbitrator, court appointed expert in various parts of the world under many different applicable law. Amongst the matters handled are disputes related to car distributorship contracts, the charter of vessels, construction matters, defects of the construction of a power plant, the design, manufacture and delivery of a turbine unit including heating condensers for a biomass cogeneration plant, delivery of goods, lawyers' fees, distribution and delivery of lubricants, exclusive import-distribution agreements, franchising agreements, international investment matters, IT services contracts, leasing contracts, the liability for the delivery of contaminated soil materials by a subcontractor, license agreements for generic pharmaceutical products, management companies, the organisation of cruises, performance bonds in international construction contracts, real estate matters, the "res judicata" effect of an arbitral award, the sale of carbon emission rights, sales of goods contracts, sales of intellectual property, sales and license agreements for algorithms, sales of machines, sales of ships, service agreements, shareholders agreements, share purchase agreements, the sponsorship of a television show, the supply and installation of a product handling system in steel plants, the termination of exclusive distributorship agreements, termination of cooperation agreements, terminations of joint venture companies, trade sanctions.
