Besides of the above-mentioned expertise, Dan Mihai is offering legal consultancy for: (i) some major national and international sport events that are currently held in Romania, (ii) for professional football clubs, (iii) for individual athletes and coaches at pro level as well as (iv) for Romanian Federations.

Dan has been recently also appointed as a member of a temporary consultative body of 4 persons established by the Romanian Football Federation as result of a court decision to dissolve the entity that organized the football activity in Bucharest area (oct 2024- current).

Dan offers also legal consultancy to other international sport lawyers regarding aspects of national laws.

#### His activity involved:
